LAST WILL AND TESTAMENT

I, GERTRUDE O. FRANCLEMONT, of the Town of Tonawanda, County of Erie, State of New York, being of sound mind and memory, do hereby make, publish and declare this to be my Last Will and Testament, in manner following, that is to say:

FIRST: I hereby direct that all my just debts and funeral expenses be paid as soon as practicable after my decease.

SECOND: I direct that my executor hereinafter named have my remains buried next to those of my husband, FERDINAND N. FRANCLEMONT, in PINE HILL CEMETERY, and I further direct my executor to retain DIETRICH FUNERAL HOMES, INC., Kensington Avenue Home, as my funeral director.

THIRD: I give and bequeath my sewing machine and my cedar chest, together with the contents thereof, to my granddaughter, JANICE EILEEN WASSINGER.

FOURTH: All the rest of my furniture and household equipment presently at 879 Parkhurst Boulevard, Town of Tonawanda, County of Erie, State of New York, I give and bequeath to my son, HERBERT R. FRANCLEMONT.

FIFTH: All the rest, residue and remainder of my estate, both real and personal and of whatsoever kind and nature and where-soever situate, I hereby give, devise and bequeath to my children, GERTRUDE MARIE THOMAN, RICHARD W. FRANCLEMONT and HERBERT R. FRANCLEMONT, me surviving, in equal shares.

LASTLY, I hereby nominate, constitute and appoint my son, RICHARD W. FRANCLEMONT, executor of this my Last Will and Testament,

and in the event that my said son, RICHARD W. FRANCLEMONT, shall predecease me or otherwise be unable to act, then I hereby nominate, constitute and appoint my son, HERBERT R. FRANCLEMONT, executor of this my Last Will and Testament. I hereby direct that my executor shall not be required to give any bond or other security for the faithful discharge of his duties as executor and I hereby give to my executor full power and authority to sell, mortgage, lease and convey all property, real or personal, with which I may die seized, upon such terms and conditions as to cash and credit as he may deem advisable, and I hereby revoke any and all former Wills by me made.
